### Workshop Themes - Mr. Lucas Mprechas, KAPA Network

- Which are the different entities that fall under Social and Solidarity Economy? Do all types of cooperatives belong in the social and solidarity economy (e.g. agricultural, civil, social, etc.)? What is the European definition of the Social and Solidarity Economy? Is the adoption of cooperative principles and values a sufficient condition to be a part of the Social and Solidarity Economy? Does the legislation governing the Social and Solidarity Economy enterprises and organizations need to be linked to the International Cooperative principles?
- Several European countries have legislation on social cooperatives; some of them also have separate legislation on social enterprises (or similar concept). Other European countries have legislation on social enterprise but not on social cooperatives; in this case, it may be possible to combine the social enterprise legislation and the general cooperative legislation. Social cooperatives and social enterprises are clearly distinct in their legal and institutional status in all these contexts. Do you think this should also be the case in Greece or should the legal status of "Social Cooperative Enterprise" as per the current SSE law remain as it is?

• Is collaboration with international organizations in amending SSE legislation and consolidation and review of cooperative legislation of value? If so, how has this worked in other contexts? How would you think it could be done in Greece?
